EFFECTS OF OVEREXPOSURE:

Acute(Skin or Eye Contact): Causes skin and eye irritation which can lead to dermatitis with repeated overexposures.

<u>Ingestion:</u> May cause gastrointestinal irritation, nausea, vomiting and diarrhea. <u>Chronic:</u>Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage. Overexposure to Xylol and Toluene in lab animals has also been associated with liver abnormalities, kidney, lung, spleen and eye damage as well as anemia. Effects in humans have included liver and cardiac abnormalities.

EMERGENCY AND FIRST AID PROCEDURES:

<u>Inhalation:</u> Remove from exposure, restore breathing and notify a physician.

<u>Eye Contact:</u> Flush immediately with large amounts of water for at least 15 minutes. Notify a physician.

<u>Skin Contact:</u> Wash affected area with soap and water, remove contaminated clothing and wash before reuse.

<u>Ingestion:</u> DO NOT induce vomiting. Keep person warm, quiet and get medical attention. Aspiration of this material into the lungs can cause chemical pneumonitis which can be fatal.
